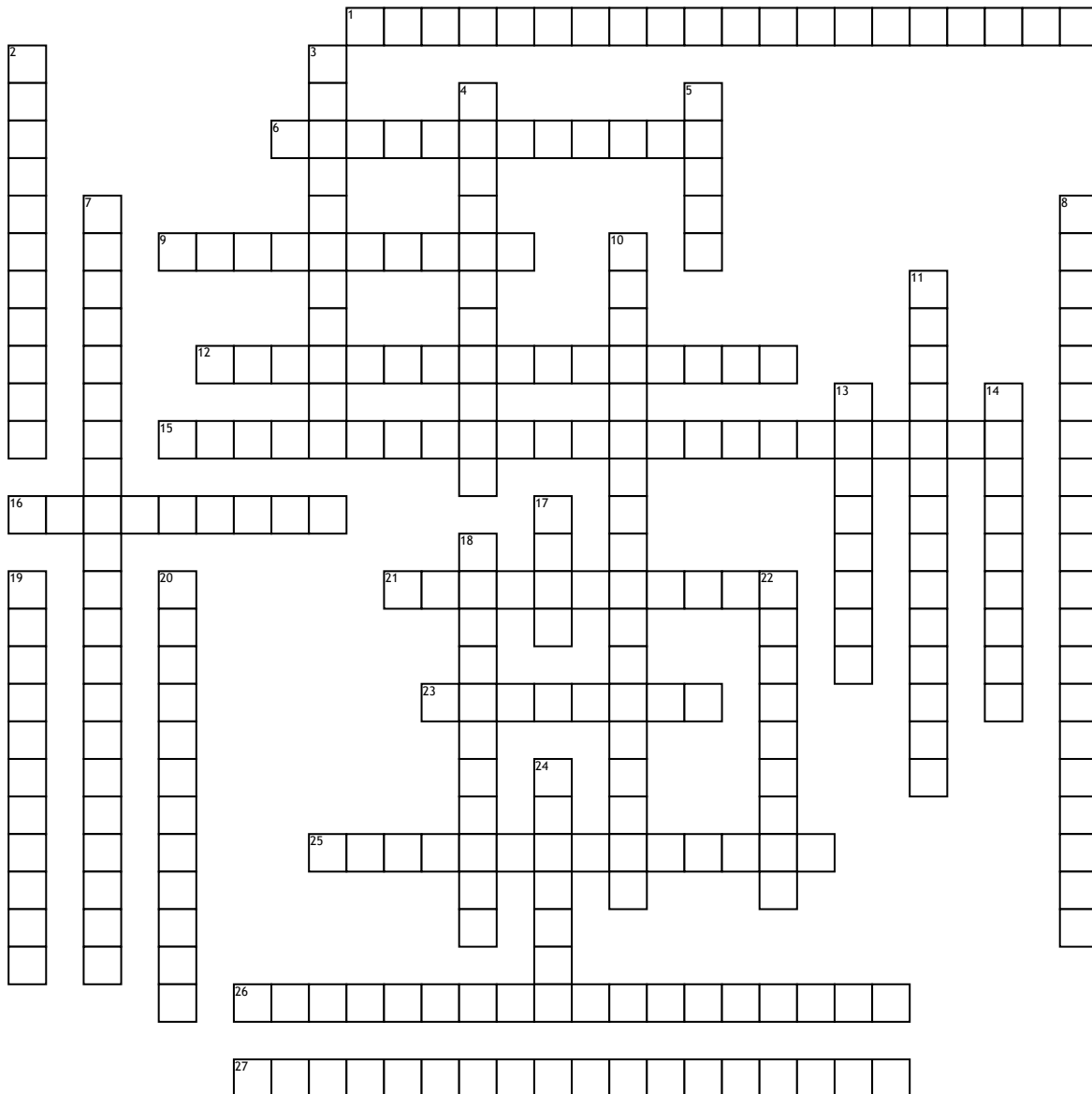

1. a nonprofit organization sponsored by local businesses to provide general information on companies
6. firm with four or more business making unrelated products, with no single business responsible for a majority of its sales
9. an organization of workers that tries to improve working conditions, wages, and benefits for its members
12. the combination of two or more firms competing in the same market with the same good or service
15. nonprofit organization of professional or specialized workers seeking to improve working conditions, skill levels, and public perception of its profession
16. measure of business profits determined by subtracting all expenses, including taxes, from revenues
21. unincorporated business owned and operated by two or more people who share the profits and responsibilities for debts

23. check that transfers a portion of the company profits to stockholders usually quarterly
25. a corporation that has manufacturing or service operations in the number of different countries
26. an unincorporated business owed by a single person who is responsible for its liabilities and entitled to its profits
27. form of partnership where one or more partners are not active in the daily running of the business, and whose liability for the partnership's debt is restricted to the amount invested in the business
